ENTRY AND PAYMENT PROCEDURE - Each Entry for this Meeting must be made using the KOMP

NOTE:

- 1. All Cadet D grade and Junior D grade drivers must have at least 2 D to C grade endorsements before entering a Zonal, State Series, State Cup or State Trophy event
- 2. In Accordance with the 2024 Victorian State Regulations Cameras are Compulsory and are to be fitted from first practice session.

MINIMUM ENTRIES

If less than eight (8) genuine are received to constitute a Class by the listed close of entries then the Class will NOT be contested. All drivers whose entry is not accepted for any Class shall be notified as soon as possible and entry fee will be returned. 32 Track capacity will only be taken for each class, once this is reached then you will be put on a waiting list.

ADMINISTRATIVE CHECKING

In lieu of an administrative checking session an Official Entry List including transponder numbers will be posted on the Official Notice Board the afternoon of Friday 6th December 2024. It is the responsibility of the Competitor to ensure that all information on the Official Entry List is correct. Any inaccuracies or discrepancies are required to be notified to the Chief Timing Officer no less than 60 minutes prior to the start of Practice for their respective Class

METHOD OF RACING

Timed Practice	One 8-minute session	
Qualifying	One 6 Minute Session	
1 st , 2 nd & 3 rd Heats	5 minutes plus 1 Lap	
Final	9 Minutes plus 1 Lap	

- Grid positions for Qualifying will be based on times from Timed Practice with the fastest on grid position 1, the second fastest on grid position 2 and so on.
- Grid positions for Heats 1 & 2 will be based on the results of Qualifying with the fastest time on Pole position, the second fastest time on Grid position 2 and so on.
- Total accumulated points from Heats 1 & 2 will determine the Grid positions for Heat 3
- Total accumulated points from Heats 1,2,3 will determine grid position for final.
- Finishing order of the Final, determines the winning positions of the Class

Points System

- Zero Point System for Heats
 1st 0 Points / 2nd 2 Points / 3rd 3 Points and so on with one point added for each place
- Non-finishers to be awarded a finishing position based on the number of laps completed.
- DNS and DSQ to be awarded the field plus one.
- Final only counts for all classes.

Trophies will be awarded for 1st, 2nd, 3rd place for each Class on the final day of the Meeting.

Black plate awarded to the winner of each class. All Place getters MUST be in Race suit for presentation.

GENERAL REGULATIONS:

KART RETRIEVAL:

Pit Crew with trolleys will not be given access to the Circuit during Timed Practice and Racing.

Retrieval of Karts is at the discretion of the Clerk of Course.

Pit Crew must only enter the Circuit when permitted by the Grid Marshall and then only if wearing a high visibility safety vest on the upper torso. Karts can be retrieved via access through the In Grid.

SCRUTINEERING:

Scrutineering for this Meeting will be in accordance with the provisions of the Technical Rules, Chapter 6 of the KA Manual. The distribution Engine tags and tyre scanning will be in the technical shed in accordance with the timetable.

FRONT FAIRING (Technical Rules, Chapter 1 Rule 8 g) (iii): The Front Fairing Fitment Rules Will be used at this Meeting.

CONTROL FUEL:

In accordance with the provisions of the Technical Rules, Chapter 3, Control Fuel will be used for this Meeting and can only be purchased from:

(i) Fuel Brand: BP Ultimate 98(ii) Fuel Type BP Ultimate 98

(iii) Service Station Name: BP TRUCK STOP

Service Station Address: Cnr Wilsons Rd and Henty Highway (Ring Rd) Portland

- (iv) Fuel for the Meeting can be purchased from Thursday 5th December to Sunday 8th December 2024

 *Proof of purchase receipts must be retained and produced to the State Technical Officer as and when required.
- (v) Control Fuel MUST be used from 8am Saturday 7th December 2024 until the conclusion of the Meeting.

Random samples of Competitor's fuel may be taken during the Meeting and tested for conformity to samples of the Control Fuel taken from the supplier on these dates. Competitors are reminded that fuel tanks and drums should be empty prior to be used for fuel purchased for this Meeting. No dumping of fuel is permitted on site.

Video Recording Systems - Recording Medium (SD Card) Procedures

- a) It is compulsory for all Competitors to fit a camera to their Kart in a working condition from the start of the first practice session at this Meeting. Failure to do so will result in Disqualification of the Competitor from the next practice session. In the event of it being the final practice session of the day the Competitor will start from the rear of the grid in qualifying.
 b) A separate SD Card must be used for each Class contested at this Meeting.
- c) Prior to the commencement of on-track activity on each day of a Round, the Recording Medium used in the camera fitted to a Kart must be completely cleared and reformatted.
- d) No recorded vision on the Recording Medium may be deleted from the time that on-track activity has commenced on each day of a Meeting until 0700 hours the next day, without the prior written permission of the Stewards.
- It will be mandatory for each Kart competing to have a video recording system that is mounted in accordance with these Rules and be fully operational at all times while the Kart is on the Track: Technical Rules Chapter 1 Rule 8.









Transponders

MYLAPS compatible transponders must be mounted in accordance with Technical Rules, Chapter 1 Rule 8 i)

Note: All Karts MUST have fitted and correctly charged and operating transponders for all sessions commencing from First practice.

TYRE SCANNING:

All competitors must present their race tyres for <u>scanning at the appropriate time on the race meeting timetable.</u> If an Event is declared "Wet", Competitors will be required to present Wet Weather Tyres for scanning or marking as directed by the Officials.

NOTICE BOARD LOCATION: Official notices will be posted on the Notice Board Wall Under Veranda .

<u>VEHICLE ACCESS</u> –

NO VEHICLES PARKED INSIDE THE PIT AREA AT ALL TIMES. NO CARAVANS IN PIT AREA

CAMPING - Camping is permitted in designated areas

SECURITY: Security will not be provided.

Unless specifically approved by the Club, Type C Structures Will Not be permitted to be erected at this Meeting.

All Structures must only be erected in areas approved by the Club

All Structures must be properly secured to the ground in accordance with the TFS Rules
